Monterey Bay Aquarium, as a founder of the Aquarium Conservation Partnership, [has gone further](#), We’ve eliminated all single-use plastic in our café and restaurant, and worked with vendors to cut back on plastic packaging on gift store items. Now, many local jurisdictions, like [Carmel-by-the-Sea](#), are adopting their own bans on single-use plastic straws, cutlery and take-out foodservice containers. Steps like these demonstrate the far-reaching impact of California’s action to ban single-use plastic grocery bags.” **Aimee David**.
